2024 Rules & Regulations



- 1. Competitors must be a Canadian Citizen.
- 2. Competitors are responsible for their own expenses incurred.
- 3. Global Country employees, volunteers, sponsors, immediate family involved with this event, Global Country Rising Stars and Alumni, or winners from previous years (Global Country) are not eligible.
- 4. Individuals with a recording contract with an independent, major, national or multinational label, a management or agency contract, or major market radio airplay <u>are not</u> eligible.
- 5. Competitors must be a "solo or duo" act only.
- 6. **Submissions and auditions will be taken online**. Video can be uploaded to YouTube or send by We Transfer (free) with link sent to maryannegibson@globalcountry.ca
- 7. Competitors must submit <u>a video of their performance and a one-page on their plan</u> & goals to pursue a career in "Country Music"
- 8. Competitors must submit **two songs for their online audition**, including one **country cover song**. The second song can be an original or cover.
- **9.** Competitors may sing to a recorded track with no lead vocals, and limited background vocals or accompany themselves on a solo instrument. They may also submit a performance video with a band as long as the music does not overpower the vocals.
- 10. If you wish to provide a short introduction to yourself with your performance video you are welcome to do so but you must also submit the one page written submission. <u>Total</u> audition presentation shall not exceed 10 minutes.
- 11. Entry forms, including registration fee, must be received in the Global Country Office by 11:59 PM, Wednesday, May 1, 2024. Incomplete, ineligible forms will not be accepted. Please ensure all forms are legible and all spellings are correct. **Registration fees are non refundable**.
- 12. Judges will make their decision based on vocal ability, performance, star quality, stage presence, overall talent, and marketability. The business plan submission and a follow up interview will also be a large component of this year's process. The judges decision is final.
- 13. The winner of Country Star Search must be able to provide proof of passport eligibility in case of travel. **Must be able to travel to the US** and have no prior issues that would prohibit this travel.
- 14. Global Country, Country Star Search committee, and Black Gold Media, have the right to photograph, film and/or sound record performances for promotional purposes in any publications, other advertising media or online without limitations.
- 15. Global Country, Country Star Search, Black Gold Media, their officers, volunteers, directors, employees, sponsors, and agents are not responsible for any claims, any loss, causes of actions, grievances, or damages.
